BOARD OF TRUSTEES ANNUAL REPORT (Submitted by Alex Saksen, Board President)

This past church year has been another in consecutive years of tumult, uncertainty, and disruption. Fortunately for our community, the alterations have largely resulted in positive movement towards whatever portions of "normal" we are able to recover after the pandemic. While we suffered through several waves, likely not the last, we have also enjoyed the added comfort of vaccines and increased knowledge assisting our Covid efforts.

With those, we have returned to in-person services for those that feel comfortable while simultaneously retaining the online version for those that remain cautious. As I write, we stand ready to return to coffee hour. Craft group is meeting in person, RE class attendance is up and a new group – "Team Fun" – promises to get us up and going with monthly social events starting this summer. The Board stands ready to support efforts at a safe return to a new normal.

Service as your President has been made easier by the tireless and humbling work of the Board. Vice President Jen Suehr was born for a leadership role. Not only has she been a regular voice of calm and reason on the Board, but she has assisted with moving the Capital Campaign planning along and interfacing with our outside consultant. We are lucky to have her as our President next year, as you will all soon see. Past President Julie Kant has been, well, Julie Kant. She has helped with everything from the Memorial Garden to keeping us all on task at Board meetings. She is UUism personified. Connie Ritzert served many roles as well, including on the Gathering Task Force where she provided unique insight from the perspective of a choir member. If the Board did not have her input through this past year, it is unlikely Sunday Services would look or sounds like they do today. Hal Dixler served as the Board's North Star on a number of difficult topics and as our de facto historian to ensure some of the newer church members (including your President) retain the spirit of the church. Allyson Zadnik's work on the Board and throughout the church is simply humbling. In addition to her Board duties, she served on the Gathering Task Force, the Sunday Services committee, and assisted with RE classes. If we had a "Volunteer of the Year" award, Allyson would be my nominee. Last but certainly not least is Beth Zak. I could write this entire report about Beth's leadership, consistency, and resolve through some very difficult decisions and discussions this past year. She is simply an amazing leader. When she speaks, she considers each of you in her thoughts. You have 6 amazing board members in whom I am in awe. Please extend them a thanks when you get a chance.

Our staff has been hard at work too. Rev. Jane has instituted office hours - both virtual and in person and works hand-in-hand with the Board to revive the in-person activities in church. For those of you wishing we moved to return to normal faster, Rev. Jane is your biggest advocate. Dana Poss deserves special credit for enduring the uncertainty of our return to church activities. Our beloved children have been a special case in terms of vaccination eligibility and attendance throughout, and Dana's counsel is invaluable. As a parent in this church, I cannot thank her enough for steering our children's religious education through rough waters of Covid, a paucity of teacher trainings offered by the UUA, and other challenges. Yet RE remains vigorous and engaging. Along with volunteers, Dana deserves tremendous thanks. Our Office Administrator Sona has been a true partner of mine through this year, making exceptions for my tardiness and covering for my mistakes – typographical and material - that none of you will ever know about because she caught them. With so much of our activity remote, she also serves as a traffic control for our church. She too deserves your thanks. Same goes for our sexton Pat Bauer. He continues to provide us timely and high-quality work while saving the church thousands of dollars. Mary Doubleday also amazes me. Our choir has returned from a long slumber. They still sound as amazing as if they had no time off. Lindsay Scott has kept our lights on and so much more through some seriously challenging times, working tirelessly on both the Finance and Stewardship Teams and assisting with a number of organizational challenges.

Because of all of the above, and you all in this community, the state of our church is healing and growing. After the past 2 years, that is cause for celebration.

I wanted to lift up a few developments at and in our church this year.

<u>Memorial Garden</u>. Peggy Trevanion, Chuck Berry, and Julie Kant have been working tirelessly for several years and the fruit of their labor is now the beautiful memorial garden on our grounds. It looks simply lovely. I encourage everyone that has not visited to do so. It is a place for peaceful contemplation unmatched in my searches of the north hills.

<u>Fiscal</u>. The Board will present its Budget for the coming church year at the June 5, 2022 Annual Meeting. In arriving at its Budget, the Finance Committee sought input from all committees and teams, monitored stewardship progress, and made appropriate alterations. This proves to be a challenging year, but one for which we have an equally vigilant team. The Board is confident the Budget, as presented, is achievable in implementation and permits our church to continue operations. It is also possible because of the tireless work of the Stewardship Team, led by Robyn Travers (another volunteer with seemingly endless energy). This year, stewardship returned to personal canvassing. From my perspective, this not only assisted in our fiscal efforts but served as a vehicle to increase interpersonal interaction. Add to these efforts the Craft Group sales that beautify our homes and add to our coffers, the grocery card and coffee sales (another chance to see each other), and the fundraising committee's upcoming Art auction, and the UU ability to multitask fundraising with social enrichment is on full display. In these trying financial and social times, these groups are to be applauded for doing work necessary for us to be here.

<u>Sunday Mornings</u>. We are now settled in the hybrid service format so many churches aspire to. For this, the Board wants to extend a heartfelt thank you to those that make this possible. Bruce Travers, Don Nelson, Nancy Kepner, Joyce Kepner, Bill McAdams, and others make possible in our church what many other congregations have spent thousands of dollars to achieve and still not gotten right. I cannot overstate the value of our Tech Team. No matter how you enjoy your Sunday mornings, the Tech Team makes it easier and better. I would also like to lift up the Worship Associates, Cantors, Pianists, and other musicians under the leadership of Mary Doubleday, and the Sunday Services Team for their understanding of the ever-changing forecast of what we plan to do week over week.

Speaking of those changes, another team I want to lift up is the In Person Gathering Task Force. This group – Allyson Zadnik, Andy Zadnik, Connie Ritzert, Barb Draa, Carol Watkins, and Mark Swihart have been a dream team of cautious optimism. That our church has made it thus far intact and without a major covid breakout is something to be celebrated. The Board thanks these folks for their leadership.

Capital Campaign and Strategic Plan. Under Chris Hill's leadership, our church now has a Strategic Plan! This was a vital step towards our goal of commencing a capital campaign next year. In short, to know if we can go somewhere, we have to know where that "somewhere" is. Chris and his team discovered that through efforts made more difficult by our time apart. Despite this, our plan is wonderful. In a classic case of Chris Hill being Chris Hill, he wasn't done there. He then joined the Capital Campaign Committee, led by Carol Ballance and Joe Meier. This group has worked seamlessly with our outside consultant to develop three plans for the church's consideration through research, speaking with contractors, interviewing stakeholders at our church, and holding town halls in various formats. The result of this is the vote to proceed with a long overdue capital campaign on the ballot this year. I would specifically like to lift up these efforts, as the timing is not ideal. However, our structures and grounds know only the passage of time, not the pandemic. A building does not quarantine its decay while we shelter in place. We need the funds to make these improvements now despite the time apart and these groups' persistence will benefit us all in the years to come.

<u>Document Management and Website</u>. Another goal for this past year was to streamline our document management systems and reimagine our website. Through the work of the Communications Team and the office staff, both goals have been achieved. A special thanks to Joyce Kepner and Fred Geiger for these efforts. Our new website is beautiful and exponentially more user friendly. Our online and hard copy document system is in place and groups are working to bring their institutional knowledge into a retrievable format. While not the sexiest church activities, these efforts will not only improve our operations but also increase our membership.

In the coming year, lets continue the work but also have some fun. Organizationally, the hope is that we will work together for a successful capital campaign. Perhaps aiding that goal are the efforts underway to just start having fun together again!

As you each feel comfortable, or how you feel comfortable, I encourage each of you to set aside your work and volunteer clothes, take a breath, and simply enjoy our church. The chances to do that communally will hopefully continue to increase. There is an appointed time for everything, "A time to break down, and a time to build up; a time to weep, and a time to laugh; a time to mourn, and a time to dance." While we are not clear of the pandemic, my wish for this church is that the coming year brings more time for building up, laughing, and dancing.

MINISTER'S REPORT (Respectfully submitted by Rev. Jane Thickstun)

Last year's annual report was full of optimism that after a year-plus of pandemic, we finally had vaccinations, cases were going down, and we were looking forward to being together again in person, certainly by September. Alas! Our hopes were dashed by a large resistance to vaccination and the Delta variant, then the Omicron variant.

At this point, it seems like it may be finally relatively safe to come together in all the ways we wish. Some of us have been worshipping in person since October, and we've now made masks optional and are ready to start having coffee hour again. Of course, not everybody feels safe enough yet, but for them and for congregants at a distance, we are still live-streaming our services on YouTube (and will continue to do so from now on).

It's a joy to see the children coming back, two years taller! I look forward to inviting them up front for the Time for All Ages in the fall. It has been a rocky two years for our Faith Development program, with all the back and forth of the pandemic, all the planning and re-planning and planning yet again. It is so hard to keep the young ones' attention on a Zoom platform. We can be grateful for the skill and compassion of Dana Poss, our Director of Faith Development. Our newly-married DLFD!

And what a blessing that our choir has been singing in person (masked) all year! The beautiful sound they make and the number of folks who come out to sing—these are a testament to the many abilities of our Music Director, Mary Doubleday.

One of the big accomplishments this year is the construction and implementation of a new website, thanks to the Communications team and especially Fred Geiger. It not only looks good, it is designed to be particularly welcoming to people checking us out, putting us higher in Google searches and allowing us to track traffic to the site. We owe many thanks to our Office Administrator for her dedication to the entire process, in addition to the many other tasks that fill her time for us.

Our beloved barn is in good hands with Pat Bauer and Mark Swihart working as a team. And our finances are also in good hands with Lindsay Scott. Her monthly reports are concise and informative, and she gladly handles extra requests.

One team that has made great strides this year is the Green Sanctuary team. They are working with other UU congregations at similar stages in the process of accreditation, and going strong on an environmental justice project with HEARTH, a shelter for victims of domestic violence. They're also looking into ways to help us recycle better, and more. Be sure to read their annual report.

Our Systemic Change team has been active with PIIN and UUJusticePA, and in providing forums with Faith in Action—our partnership for racial justice with St. Brendan's Episcopal and Trinity Lutheran. There is more, too, and I refer you to their annual report as well.

I can't cover all the good things the people in our community are doing, so please read all the reports! I do want to lift up the Covenant Group program, now finishing its second year. The facilitators meet with their groups twice a month, and with each other and me once a month. They are doing a most important ministry. If you haven't participated yet in a group, we'll be forming new ones in September.

And I want to especially thank our Sunday Services team, who have put on top quality services on my Sundays off throughout the year, including last summer, and they're ready for this summer. It's a small group handling a big job, and handling it well. While all our teams want new members, if you are creative and like to design and implement a product that reaches people's hearts and minds, this team is for you.

I invited Miguel Sague of the Three Rivers Council to speak to us in the Jan 16th service about the Native community in Pittsburgh—historically and today. It was a pleasure beginning a relationship with this community, and I hope we will continue to be involved with them. We have added a land acknowledgement to the welcome words of our service, in recognition of the fact that we occupy stolen land.

The Stewardship team went to town this year, organizing a face-to-face canvass. Many volunteered to be canvassers, or visiting stewards. We appreciate their efforts greatly, even if we didn't take in what was needed.

The Ministry Council has been helping the teams implement the recommendations in the UUA's Widening the Circle, a report on how Unitarian Universalism is dealing with issues of race internally and externally. Due to the efforts of the Council and the teams, we have become more aware and more active as a congregation in addressing the culture of White supremacy. Let's keep up the good work!

We have had some losses in the community this year, including Lou Bartolomucci's son James, Carol Kline's partner Barb, and Judy McAuley's mother Sally Libson. The Zaks lost Mike's mother Jean and a niece, Alicia Drosendahl. Long-time member Dawn FitzGerald Swidal died unexpectedly in November. And most recently, Lynne Herchenroether lost her husband Keith, also unexpectedly. We also held memorial services this year for Lorenzo Pane and Tom May, who died in March of 2021. Our hearts are with all the members of our community who are grieving losses large and small.

It is so nice to see people in person again. If you haven't been to a service in-person since the pandemic shut things down, I hope you come back soon! Let us hope and pray for an end to the threat of the virus, and many face-to-face gatherings to come.

ADULT FAITH DEVELOPMENT GROUPS

JESUS DISCUSSION GROUP (Submitted by Tony Palermo)

With the goal of presenting the Jesus of history and scholarship, this group has met, one Sunday per month, at UUCNH since 1992. Over 300 people have stayed an average of 5-6 sessions each.

Presentations involve an approximately 2-year cycle, beginning with the evidence for the historical existence of Jesus, and then delving into what the biblical or extra-biblical evidence, tells us about the man from Galilee: his family, occupation, philosophy and quotes, along with his birth religion and cultural milieu.

From that point, the gospels are discussed in detail: authorship and time of composition, as well as editorial concepts. Special note is made of the trajectory of various notions of Jesus' status on the way to divinity. Stopping points along the way include the Nativity stories [purpose and divergences in Luke & Matthew], the events of his week in Jerusalem – arrest, death and resurrection – and the development of thought about Jesus as the Son of God, a process covering 300 years of history and "heresies."

Some topics have been added by request: Jesus and Mysticism, the epistles of Paul, Gnosticism and the Apocryphal Gospels, among the most popular. The presentations are open. Questions and discussions

are always encouraged, and usually happen. Attendees in the past have ranged from Christians to agnostics to atheists to Eastern adherents. All points of view are respected.

Interested individuals need not be there for the beginning of each topic; a summary of previously covered material always begins each session. Special topics this past year have included the oral stories that predated and helped form the written gospels, as well as the influence of the Roman Empire on the development of the Christian movement.

PSI (PHILOSOPHICAL, SPIRITUAL INSIGHTS) GROUP (Submitted by Tony Palermo)

The goal of this group has been to look for meaning and connection in the Worlds of Science, Philosophy and Spirituality. As an off-shoot of the Jesus Discussion Group in 1995, the members began with a search for an understanding of Christian Fundamentalism but quickly moved on to the mysteries of Philosophy, Physics, Chemistry, Biology and Evolution, including spirituality and the brain, medical ethics, communication with the Divine, Eternal Life, interpersonal relationships, the molecules of Life, and the development of human nature through Darwin's theory of Sexual Selection.

A particularly popular topic has been the psychological nature of Evil, and the notion that despite the horrors of the evening news, humanity as a whole is becoming more moral with passing years. Each topic was/is based on at least one landmark book in its field and presented once a month in open discussion form. As with the Jesus Discussion Group, questions and differing opinions are encouraged and afforded respect.

PSI has also seen a few hundred attendees over the years. Some stay for an entire topic, as many as 6-7 sessions, some for a few years. And as with the Jesus Discussion Group, one does not need to attend from the start of each topic; a summary of previously covered material always begins the session. Currently, we are discussing the possibility of productive, rewarding communications across scientific, religious [or other] paradigms.

FELLOWSHIP GROUPS

CRAFT GROUP REPORT (Respectfully submitted by Irene Dinning, Chair)

The Craft Group meets on Thursday mornings from 10 to noon in the West Room. The meeting is also available on Zoom. If the weather is good, we bring our folding chairs and meet outside at the church.

The Craft Group (formerly the Craft and Rummage Group) is one of the oldest if not the oldest group within the church. When the church was in its early years and did not have much money, the women (many who did not work outside the home), held sales and used the money to buy extra items which were not in the budget. The Group kept their money in a separate account in the church treasury. Today we no longer hold rummage sales but we still hold craft ones. We still keep our money separate and we still use it to buy unbudgeted items to make our church a better home.

We hold two sales each year – one in the spring and one in November/December called our Holiday Sale. This year we held both sales online but also had a few tables with extra items for our Spring sale in Friendship Hall. Hopefully we will back to in-person sales for the next Holiday Sale. The craft group also

supports each other with caring and sharing. We have members who are not crafters but love to come and join in our spirited and interesting discussions. We have about 30 members.

ACCOMPLISHMENTS: During the 2020-2021 church year, as the community became more accustomed to our virtual world, we adapted by providing a mixture of Zoom and socially distant, in person programming.

PREK-6TH GRADE PROGRAMMING: CARTUUNS

A brief introduction to CartUUNs, from the curriculum book:

"This curriculum uses animated shorts from Pixar and Disney to facilitate discussion around values, ethics, and feelings. The shorts are short in length, with most running between three and eleven minutes; the short length will alleviate boredom, and allow all children to see the animation in its entirety, grounding the discussion in a shared experience."

This format was perfect for our Zoom classes with the younger children; our classes ran every other Sunday from 9:30-10am, and included chalice lighting, check-in, a short film, related questions, and a craft. The children enjoyed sharing their crafts and their activities with the class. Though our classes were small, we had a core group of participants each time, and tried to keep our time together as engaging and fun as possible.

During our last class before the holidays in December, we watched *Olaf's Frozen Adventure*, drank hot cocoa, and made snowmen on paper out of marshmallows, while discussing some of our favorite holiday traditions. Due to the virtual Sunday school format and lower attendance than we tended to see in person, we opted not to have a holiday pageant this year; the hot cocoa party, while not the same, helped get everyone into the holiday spirit.

In recognition of Earth Day in April, we leaned into embracing a positive aspect of our new virtual world - the ability to connect outside of our local area - with a Zoom nature visit for families with the Denison Pequotsepos Nature Center located in Mystic, CT. The staff of the nature center led a program called Animals! Animals! Families were able to see a variety of live animals like turtles, frogs, snakes and birds that can be found in Connecticut and discover similarities and differences between them.

Then, in May to finish out the year with a multigenerational event, the team organized a stuffed animal sleepover at UUCNH. Anyone of any age was welcome to participate. The team posed the animals engaged in various activities at the sleepover such as singing in the choir, listening to a worship service, having breakfast together and snuggling up for their favorite movies and snacks before bedtime. The team then shared the photos on the UUCNH Community Facebook page for all to enjoy.

YOUTH PROGRAMMING: CROSSING PATHS

We had planned for 2 years to offer a Neighboring Faiths type of class for youth this year. When the pandemic forced many houses of worship to shut down, we thought we might have to postpone this program for another year. Luckily, the folks at Soul Matters quickly revised the Crossing Paths curriculum to be conducive to an online format. More information from the Crossing Paths website:

UNIQUE COMPONENTS: Crossing Paths joins the long line of visit-based UU curriculum going back 70 years. *Church Across the Street* was published in 1947. More recently, we've seen Neighboring Faiths (1997) and Building Bridges (Tapestry of Faith). Our Soul Matters versions honor these previous curricula and adds its own unique components, including an emphasis on theological grounding, a distinct take on religious pluralism ("Many Mountains, Many Paths"), and an abundance of experiential learning and a deep commitment to family-centered activities.

UU IDENTITY FORMATION: While the program is built around interfaith engagement, its focus is really on UU youth identity formation. We not only lift up the core pieces of other faiths, we also compare and contrast those faith's beliefs and practices with those of our UU faith. By exploring those similarities and contrasts, youth are better grounded in their faith and clarify their own particular UU identity.

We were able to find a team of volunteers willing and able to try this class virtually. The group spent 2 Sundays learning about a particular religion or faith tradition followed by a Zoom visit with a local faith leader. They learned more about Unitarian Universalism, Christianity, Judaism, Islam, Buddhism, and earth-based spirituality. The virtual visits were really the capstone of this program, with the youth and adult facilitators stating that they learned a great deal from the faith leaders they met with.

YOUTH PROGRAMMING: YOUTH GROUP

As with most other church activities, the Pandemic put a new twist on how Youth Group was done this year. We continued to have monthly discussion meetings, just via zoom instead of in person. As such, our attendance numbers have been lower than last year. We have, however, maintained a small core group of dedicated youth that have attended throughout the year.

When the weather has allowed, we have also organized some outdoor, socially distant activities such as a bonfire, outdoor games, sledding/snowball fight, and an adopt-a-highway cleanup. We are right now preparing for our first annual Youth Group Hike. Our most successful activity of the year was a white elephant gift exchange over the holidays. Robyn drove around and collected all of the purchased gifts, we opened them white elephant style, via zoom, and then she redistributed them to the recipients. The youth group also inspired the creation of the still-active Bucket-o-Plenty at the church. The youth group is looking forward to being together in person again soon!

CHALLENGES: This is the first church year we conducted almost entirely online due to COVID-19, which was arguably the biggest challenge. How do we offer programming to keep children and youth engaged so that we still have interest in our programs at a time in the future (hopefully during the 2021-2022 church year!) when we are able to come back to church in person?

Another challenge was getting the volunteers needed to facilitate groups. The pandemic changed many circumstances for families with many having to both work and school from home, which required more of a time commitment. Therefore, our Families Group did not meet this year because we did not have a volunteer to run it. As many of these activities took place indoors, it did not make much sense to keep it going in such a questionable time with many activity centers being closed anyway due to the shutdown. We hope that we will find a volunteer to facilitate this group again in the 2021-2022 year because the families really enjoyed the group get-togethers and coordinated activities.

PLANS FOR THE FUTURE: It is still unknown exactly when we will be able to come back to church fully in person, so at present we are preparing for both continued online programming, hybrid programming (virtual and in person) and fully in person. We expect that when we return fully in person, we may have to rebuild our CYFD program from scratch, as we welcome new and returning families. On the positive side, it is a chance for us to look at our programming across the board and make changes we have thought about making in the past but hadn't yet executed on.

BUILDINGS AND GROUNDS (Respectfully submitted by Mark Swihart)

We continue to use the model of me coordinating the various B&G activities, with professional support from our part time handyman, Pat, plus volunteer support from many members, especially the leadership team.

The main work completed in the last 12 months was:

- Interior painting and plastering.
- Front building entrance appearance improvement.
- · Rehabilitation of our main sign at West Ingomar Rd.
- Parking lot steps and landing partial rehab.
- Stop-gap parking lot pot hole repairs.
- February ice storm damage repairs.
- Dead trees removal (joint project led by Bellwood)
- Normal maintenance (it has been the year for fluorescent light ballasts throughout the building to reach the end of their life; also, a year for branch trimming).
- Various safety inspections: elevator, fire extinguishers, alarm system, emergency lighting, sprinkler system, AED unit.
- Misc. repairs including automatic light sensors, phone system 2nd line, control of flies in the silo room, fences, furniture, plumbing, electrical.

Everyone is encouraged to fill out the <u>Work Order Form</u> on the website for entering a request and/or suggestion about the church facilities. That gets the information immediately to <u>Pat and me</u>.

Thanks to the many who have made themselves available to pick up pieces of the B&G load. Lots of hands make light work, and there is always room for more help!

THE CHILDREN'S MEMORIAL FUND COMMITTEE (Submitted by Greg Jarold, Chair)

The Children's Memorial Fund was established with a gift of \$5,000 from Dennis Gilbertson in memory of his wife Virginia and their children, Christine and Eric, who were killed in a plane crash during the summer of 1962. The Fund was established "for the relief of suffering and neglected children throughout the world". Grants are made only from the interest income of the Fund and only when no other source of funding can be found.

In the years since its establishment, the Fund has grown through contributions from church members and friends. There were no contributions to the Fund this past year. The current value of the Fund is nearly \$68,000. Most of the Fund is on loan to UUCNH at the current annual interest rate of 1% less than the prime rate. During this past year the annual interest income was over \$1,200 which was added to the remaining income balance from previous years. Currently, \$4,500 is available for grants.

In the past year, the Children's Memorial Fund Committee funded a grant request of \$1,200 to contribute to scholarships to help cover fees for the summer camp program run by the Glade Run Foundation for autistic children whose attendance at the camp is dependent on the receipt of financial aid. In addition, the Children's Memorial Fund Committee funded a grant request of \$1,750 to pay for concrete needed for the construction of a home entrance ramp for a handicapped student of the Western Pennsylvania School for Blind Children. Also, the Children's Memorial Fund Committee has recently approved a grant request of \$369 to fund the purchase of a Joy Player (an accessible device that empowers a handicapped child to play music independently) for a six-year-old student at the Western Pennsylvania School for Blind Children.

In the coming year, if anyone knows of a case of a child in need where all known sources of financial assistance have been explored but came up empty, please refer the professional involved with the case

or a family member to a member of the Committee. All cases will be considered and grants made based on our financial ability and the Fund's guidelines.

The Fund is always grateful for contributions from church members and friends. Through contributions, the Fund can continue to increase its ability to help children in need.

COMMUNICATIONS TEAM REPORT (Respectfully submitted by Joyce Kepner, Chair)

The Communications Team was formed to bring the functions of the newsletter, website, Facebook page and traditional advertising methods under one cohesive umbrella, for the purpose of developing coherent communication between UUCNH members and between UUCNH and the outside world.

We have been fortunate this year to have a strong and involved team. Membership includes: Fred Geiger, our Office Administrator, Joyce Kepner (chair), Nancy Kepner, Dana Poss, Brian Sullivan, Rev Jane Thickstun and Hal Dixler. We also have had strong involvement from members of the board, the connections team and the ministry council.

Our focus this year was largely on the upgrade of our UUCNH Website:

- July October: Design and messaging sessions were held
- Our Website Infrastructure was upgraded to make our website more secure and robust. The upgrade includes:
 - A staging environment that allows us to prototype changes outside of our production environment
 - Daily backups.
 - Moving our web hosting to a local hosting service with a person available to assist if needed
- In early March, we went live with our new UUCNH Website Our target audience is both the newcomer visiting our site to learn about us as well as existing congregants needing to access community information and resources.
- Search Engine Optimization continues to be improved. As a result, UUCNH is currently ranked higher in searches.
- Our website continues to evolve and improve with your input.

Many Thanks to Fred Geiger and our Office Administrator for their continued efforts in updating the website.

COMPASSIONATE SERVICE TEAM (Submitted by Dawn Lindsay, Chair)

The Compassionate Service Team (CST) supports the mission of UUCNH to be a loving religious community by participating in direct service to those in need in our community. We hope to nurture an atmosphere of continuous outreach and service to others through ongoing and seasonal projects. CST meetings, events, and projects are open to participation by all friends and members of UUCNH.

During this church year, CST was able to bring back many of our core activities, which were on hiatus due to the COVID-19 pandemic. Notably, the Bellwood Kids Stuff sale occurred in October and March, and CST helped harvest unsold items for donation to a number of organizations. In March, the Northside Common Ministries meal was served in person for the first time since the pandemic began (the meals were delivered to the door on our regular schedule between July 2020 and October 2021.

The team is pleased to announce that the Hunger Garden and Farm Stand will return in the summer of 2022. Dick Myers has resigned as the Coordinator of the Hunger Garden, and the CST would like to thank him for his 6+ years (totaling hundreds of hours) of service to UUCNH. We have a capable team that will be taking over the Hunger Garden.

Our North Hills Community Outreach (NHCO) collections continued this year, including the School Supplies collection in July, Thanksgiving on Every Table in October, Holiday Toy Shop in December, and Spring Cleaning in May. The NHCO Food Pantry located in Friendship Hall accepts ongoing collections.

TrUUe Colors is an ongoing offshoot of the Compassionate Service Team. The focus of TrUUe Colors has been on renewing the Welcoming Congregation status through implementation of the five practices.

SHARE THE PLATE: The Compassionate Service Team collaborates with both the Systemic Change Team, Green Sanctuary, and TrUUe Colors in selecting the "Share the Plate" recipients for the year. The Connections Team consists of Chuck Berry, Joe Meier, and Cindy Mitchell. We have accomplished a lot this past year in keeping people connected.

We have:

- Hosted our first Church Picnic at North Park
- Hosted two "Meet the Church" events
- Hosted two "Exploring Unitarian Universalism" events
- Hosting a "New Member Sunday" event on May 15th
- Ran the annual Roster Review
- Planning a Church Service for late July of this year, as our response to "Widening the Circle"

COVENANTAL RELATIONS TEAM (Submitted by Lynn Richards)

The Covenantal Relations Team (CRT) has designed a written process to address serious conflicts that might arise in our UUCNH community. We stand at the ready to mediate among involved parties in cases of conflict following that written process—always with the goal of returning to respectful covenantal engagement. Our next tasks are to develop programs and materials to educate the congregation about this process and to make it easily accessible on the church website.

This year's Team was comprised of Joyce Kepner, Lynn Richards and Rev. Jane Thickstun. We are currently seeking a third member to serve on the Team.

FINANCE COMMITTEE (Respectfully submitted by Dennis Doubleday (Chair), Lindsay Scott (Treasurer), Mary Ellen Johnson, Joe Meier, Bill Moul, and Tom Yeh)

The Finance Committee manages all aspects of the church's finances. We prepare a proposed annual budget prior to each fiscal year (which runs from July 1 to June 30). During the year we meet monthly to review the current financial condition of the church. We review the statements to be sure we are staying within the budget approved by the congregation at the previous year's annual meeting. We also watch for any unusual items or changes that may require action by a committee or the Board.

When we made our budget for the 2021-2022 Fiscal year in May 2021, it was a period of hope that the COVID-19 pandemic, which has had a profound impact on all aspects of church life, would be held in check by the availability of vaccines. We budgeted for a more or less normal church year with regular attendance and activities in the church building. Because of the rise of the Delta and Omicron variants, unavailability of vaccines for the very young, and widespread vaccine hesitancy and pandemic fatigue in the United States, this proved to be a less-than-accurate assumption.

Because of a rebound in pledges, we were able to raise our operating budget for \$378,650 in 2020-2021 back to \$406,093, almost identical to the \$406,567 budget for 2019-2020.

We are not tracking well compared to April 30 of last year. You can see that Total Income was \$85,000 higher in April 2021. However, last year and this year are a little difficult to compare because last year included about \$51,000 in PPP money. Two other factors are that market investments were up instead of down last year, and our plate/non-pledge collection is well short of last year at this time. So, there is cause for concern but not alarm at this stage. We will count on an end of year surge in pledge payments to close the gap.

During the course of this fiscal year, we've also had to spend down significant cash reserves to make needed repairs on the silos and to put a new roof on the West Room. In the next few years, we also need new roofs on the original barn and on the Bellwood house. We cannot pay for this from reserves; hence the planning for a Capital Campaign during the 2022-2023 year.

To all of you who have been able to continue to fulfill your pledge commitment, we are grateful. To those who are struggling, we hold you in our hearts and hope the coming year is better.

In an attachment to the Annual Report, you will find the proposed budget for 2022-2023, which, in draft form at the time of this writing, **roughly anticipates maintaining our budget at 2021-2022 levels**. This is not ideal, since we want to give our staff wage increases and the cost of other things has gone up. Further developments will be reported at the Annual Meeting itself.

The Committee also oversees the Church Endowment investment account. This is an account originally established with a gift from the estate of a long-time church member, Elinor Allen. The church bylaws provide that the dividends and interest earned can be used to help fund the operating budget on an annual basis. To spend any of the balance of the account requires a two-thirds vote of the congregation. The balance of the account at April 30, 2022 was \$375,245.41, which, due to the market downturn, is an **8% decrease** over the balance of \$407,812 at April 30, 2021. We have not used any of the earnings for operations for at least the last thirteen years which has allowed the fund to grow at a faster rate. However, we will quite possibly need to draw on some endowment income to balance the budget on June 30, 2022.

FUNDRAISING TEAM (Submitted by Ellen Saksen, Chair, Dawn Lindsay, Lou Bartolomucci)

The Fundraising Team held an "Art From Your Attic" auction in May 2022. Over 100 pieces were donated, and over \$1300 was raised. The Fundraising Team would like to thank everyone who donated art, and helped during the event. Chuck Berry again lent his services as auctioneer, and Bruce Travers provided tech support. Set up and cleanup crew included Denise Haver, Julie Kant, and Joe Meijer. Thank you! We are planning a book swap for early summer (get your summer reading materials!) and a Goods and Services Auction for Spring 2023.

The team has three active members, and would welcome more folks who are interested in helping to plan and strategize fundraising efforts at UUCNH!

GREEN SANCTUARY (Submitted by Matthew Mehalik, Coordinator)

The <u>Green Sanctuary Team</u> continued to meet using Zoom on its regular monthly schedule on the first Sunday of every month throughout the 2021/2022 church year. This year all the communications materials and email list have migrated to Google so that all agendas, documents, and email communications are preserved in the Google system. The new email is <u>greensanctuary@uucnh.org</u>. It has 32 subscribers, and we have between 8 – 13 people participating at the monthly meetings.

The major efforts this year are related to our ongoing process of becoming recognized as an official "Green Sanctuary" by the UUA. Currently our congregation has "Candidate" status.

- We are participating in monthly Zoom calls coordinated through the UUA so that we can have
 discussions with 6 other congregations that are similarly in "Candidate" status: Horizon UU in
 Carrollton, TX; May Memorial in Syracuse, NY; Bay Area UU in Webster, TX; UU Blue Ridge in
 Sperryville, VA; Keweenaw UU Fellowship in Houghton, MI; First Religious Society in Carlisle,
 MA. These discussions involve sharing strategies, reporting on progress, and providing peer
 support.
- The GS team reached out to 8 community organizations to pursue connections for engaging in community-led environmental justice projects.
- From these 8 we have found strong connections with two organizations and have begun making progress for with both organizations:
 - HEARTH Women's Shelter we have been invited to partner in designing, constructing, and operating a community garden in support of Hearth residents. As of May 2022, the gardens are under construction. Volunteer work sessions have occurred in April and May 2022. Once the gardens are constructed, planting and training in maintaining the gardens will take place in the very near future.
 - Allegheny County Clean Air Now (ACCAN) we have been invited to support this grassroots community group in conducting door knocking as well as preparing and reading testimony on behalf of residents who cannot attend public meetings at the Allegheny County Health Department because those times conflict with peoples' work schedules. So far, we have had several participants from the GS team engaged.
- Status updates of these two projects are being drafted to be sent to Rev. Brammer at UUA. These updates should provide the needed documentation for moving our status forward with the UUA.
- As a reminder, the application can be viewed here.
- The GS team has moved forward with plans to revamp the recycling efforts at UUCNH. These efforts will be forthcoming over the course of the summer and will include new recycling bins; a schedule for who is picking up the recyclables; and updated kitchen and coffee hour practices that improve the handling of different waste streams to decrease our footprint.
- Over the course of the past year, we explored participating in a composting co-op program. That
 program was deemed too expensive and not feasible; however additional efforts are being
 examined to increase composting at our congregation.
- The GS team provided substantial input into the capital campaign process by identifying many priorities for investment from the energy and sustainability audit completed in 2019. These priorities as well as additional solar panels and landscape enhancements have provided for useful suggestions to the capital campaign.

Overall, this year marked a shift to more "doing" activities that excite the members of the Green Sanctuary Team, with more to come as the pandemic restrictions are anticipated to relax over the course of the summer and into the fall.

Once again, I appreciate being a part of this dedicated group and the opportunity to serve as their coordinator.

GOOGLE WORKSPACE TASK FORCE (Submitted Joyce Kepner, Chair)

In April 2021 the board approved our Document Management Policy providing guidance for what documents should be preserved by the Board, Staff, and Teams/Committees, and for how long. In addition, the use of Google Workspace was approved by the board to use as our UUCNH Central Repository which:

- Provides for ongoing institutional memory that isn't dependent on any one person
- Enables seamless transitions whenever staff and volunteers are added or move on

Eight teams/committees still need to transfer their documents from personal folders to our Workspace domain so future teams can benefit from their work. We are here to help you transition to our UUCNH Workspace Domain.

The past year saw the completion of Phase One of the Memorial Garden project. The paths were laid, grass seed was planted, trees were planted and we reinterred ashes and replaced memorial stones under the pergolas. There were a couple of problems. A couple of the trees died and the portions of the paths have suffered from water runoff. The trees have been replaced and we continue to look for solutions to our path problems.

All-weather benches have been selected to be used under the pergolas. Four families and friends have agreed to pay for the benches in memory of loved ones. We plan to add more landscaping and memorial walls which will be placed on the opposite side of the memorial circle from the pergolas.

All costs, so far, have been paid from donations and there have been discussions about adding the cost of the memorial walls to the capital campaign.

Diagrams and prior reports about the Memorial Garden can be found on the website – at "About" and the "UUCNH Facility and Rental" dropdown. We will be adding an update in the near future and documentation on the use of garden for ashes, memorial stones, memorial services and costs.

SYSTEMIC CHANGE TEAM (Respectfully submitted by Liz Perkins and Steve Fueqi, co-chairs)

The Systemic Change Team has continued its work with PIIN (Pennsylvania Interfaith Impact Network), UUJusticePA, Fair Districts PA, and Faith in Action as our main partners.

We remain grateful to John Ballance for his work as Treasurer of PIIN and we seek to support PIIN as it continues to re-organize and grow. A professional organizer has recently been hired by PIIN to facilitate this process.

UUJusticePA continues to provide a number of ways for UU's to engage in the preservation of the democratic process within our Commonwealth. Their teams are focused on six issues: Good Government, Environment, Economics, Gun Violence Prevention, Reproductive Justice, and Criminal Justice Reform. An effort to support citizens in voting will be resumed this spring, called UUtheVote. At least three UU's from the Commonwealth are running for state offices. We remain eager to help inform citizens and encourage their participation in voting. We also provide opportunities for UUCNH members to write postcards to legislators on current issues and legislation needing support.

Fair Districts PA is working tirelessly to promote the democratic process, now focusing on bringing reform to The Rules which govern the method by which our legislators in Harrisburg share and don't share power. Our team is eager to help educate citizens on this perversion of democracy.

Finally, our collaboration with Faith in Action is strong. We work with St. Brendan's Episcopal Church and Trinity Lutheran Wexford to produce monthly forums on topics pertaining to racial injustice. Topics have been diverse and of strong interest to issues of importance in western PA.

The Systemic Change Team welcomes new members at all times. We also wish to improve our visibility within the UUCNH community so that more people know what we are doing and become interested in joining us. We are small but mighty!

TECH TEAM (Submitted by Bruce Travers)

The Tech Team (formerly known as Audio Wranglers) are the group responsible for audio and visual equipment used at UUCNH. This includes Sunday services, church group meetings, funerals, memorial services, and weddings, and also events from outside groups that take place at UUCNH. The members are: Ethan Connor, Dennis Doubleday, Nancy Kepner, Bill Maruca, Bill McAdams, Don Nelson, Kip Ruefle, and Bruce Travers (head wrangler). Ellen Saksen and former member Mark Draa are available to fill in, if needed.

This year, we purchased an outdoor speaker system. It was used on three occasions: a wedding, a memorial service, and a Sunday service by a visiting minister who requested it. With the shutdown of live-attended services, necessitating the addition of a video camera, it seemed appropriate to change the name of the "Audio Wranglers" to the "Tech Team," although members expressed that they still wished to be called Wranglers individually.

At the start of 2021, services were being produced as recorded programs to be broadcast on Youtube, starting at 10:15 am with UUCNH Announcements and the service beginning at 10:30 am. This required only the involvement of Don Nelson, Nancy Kepner, and Bruce Travers, among the Tech Team, and was broadcast remotely by Nancy Kepner. Later during the year, Rev. Jane began to give her sermons live from UUCNH, and the Tech Team continued to broadcast pre-recorded segments intercut with the sermon. This needed to be done from UUCNH live.

Later in the year, UUCNH returned to in-person full services (with Worship Coordinators, pianist, and choir in attendance). The full Tech Team returned to duty, with the major change that each week, two Wranglers will be working. One will conduct the audio, while the other directs the camera. Services continue to be streamed over Youtube, and they can be viewed by anyone at later dates, as well.

An unofficial member of the Tech Team was added, as Joyce Kepner has agreed to monitor the live chat during services. She responds as "UUCNH" and has the power to remove comments and block posts that are irrelevant or inflammatory. This has happened on several occasions, and Joyce responded very quickly in each instance.

In the coming year, the Tech Team does not have any major purchases planned; our budget is anticipated to be used only to repair existing equipment and to resupply batteries and gaffer tape. All equipment is currently functioning well.

BELLWOOD PRESCHOOL (Respectfully submitted by Katie Helfrich - Bellwood Parent Board President)

INTRODUCTION

Bellwood Preschool (Bellwood), as a community outreach program of the Unitarian Universalist Church of the North Hills (UUCNH), submits this report to UUCNH in summary of the past school year. Further information is available upon request.

PRESCHOOL ACTIVITIES

Despite the challenges presented by the COVID-19 global pandemic, Bellwood Preschool had yet another successful year in carrying out our mission "To provide each child with the opportunity to become problem-solving, empowered, compassionate individuals who share a deep respect for their global village."

Unlike last year, Bellwood was able to hold in person activities. At times, closures were necessary to prevent COVID exposures, but more often than not, Bellwood was able to be in session. As in years past, the school follows a daily rhythm of arrival, together time, choice of five area activities (including K-Kids, our pre- Kindergarten program), outdoor activities or stories and songs, then dismissal. Children learn kindergarten-readiness skills, artistic expression, science, nature, multiple languages and cultures, respect, compassion, and responsibility, just to name a few. Bellwood prides itself on being a discovery-oriented school that provides an environment rich with experiences to help foster self-esteem, creativity, and growth for children ages two to five.

The Bellwood community extends beyond the classroom to family events such as the Fall Family Night at Soergel Orchards, Family Ice Skating event, the Winter Sing -a- Long, the Spring Art Show, and play dates throughout the year.

Bellwood utilizes many community organizations and parent passions to enrich the curriculum. These enrichment areas included: Spanish, yoga, science, history and culture topics. The theme for this year's Bellwood Art Show is inspired by the book "All Creatures Great and Small" by James Herriot. This theme has provided endless interesting discussions related to animals and their place in nature.

Some community organizations that visited this year also provided safety discussions, cultural exposure, and interesting science discussions. These visits included: The Franklin Park Volunteer Fire Department, The Pittsburgh Symphony, and Animal Friends. Due to Covid restrictions, we were not able to have our customary visits from the Carnegie Science Center or Pittsburgh Zoo, but the children had vision, speech, and hearing screens, and learned about dental health. There is always a multitude of opportunities when a child walks into Bellwood!

SESSIONS AND ENROLLMENT

Bellwood continues to offer 3 (MWF am or pm), 4 (MWF am or pm and TH am), and 5 (MWF am or pm and TH all day) session options. The am session runs from 9:00-11:30 am; the pm session runs from 12:30-3:00 pm; the Thursday full-day session runs from 9:00 am-2:00 pm. The 4- and 5-session options are reserved for children in their Pre-K year. Enrollment for the 2021-2022 year was at capacity, 64 students. 32 attended in the AM and 32 in the PM sessions.

At the time of this report, enrollment for the 2022-2023 school year is full for both the AM session and the PM session. We also maintain an extensive wait list at 30+ for openings for the upcoming academic year.

For the 2022-2023 school year, we plan to maintain the same session options, but we will evaluate our programs and policies prior to the start of the school year and throughout, to determine if we will return to / maintain all pre - COVID operations.

Additionally, we hope to be able to once again offer our Lunch Bunch and Extended Day Fridays as we did pre pandemic.

KIDS DAY OUT

"Kids' Day Out: Get Ready for Preschool" remains popular for its sixth year. This program is for two-year-old and young three-year-old children, accompanied by a caregiver. It helps ease the transition to preschool and has helped increase preschool enrollment. We offer a Fall and Spring session, each last 6 weeks. Approximately 8-10 children (with a caregiver) attend each session. This program has spread the Bellwood name further into the community and been very popular for word-of-mouth recommendations.

STAFFING

It is the teachers who are the heart and soul of our school. They create a place where children learn academics to be prepared for kindergarten, but also learn to be good citizens and to value one another. We have a staff of ten teachers to maintain the 1:6 teacher-student ratio. Two of the ten teachers, Emily Moschitta and Susan Flanders are Lead teachers/Curriculum coordinators. We also employ a part time director, Kate Campbell, and a part time office administrator. In previous years we also employed one teacher assistant but she was not with us this year due to the pandemic.

The Bellwood Board members are responsible for the collective governing of the school as well as tasks involved in facilitating the operations of the school. Our dedicated parent board is comprised of the following positions: President, Kid Stuff Sale Co-chairs, Treasurer, Secretary, Registrar, Publicity/Communications, Special Events, Family Events, Buildings and Grounds, and Yearbook Co-chairs.

FUNDRAISING AND TUITION

Our main fundraiser continues to be the Fall and Spring Kid Stuff Sales. It is because of our hardworking, dedicated Kid Stuff Sale co-chairs and parent volunteers that we are able to hold such a significant event. The sale not only raises the majority of the money used for school supplies, church donation, and building upkeep, but also provides a service to the community and the Earth! As always, we are grateful to UUCNH for the use of the building and their help on Saturdays.

Starting next year, we have decided to embed our fundraising fee into our tuition price. It is a minimal monthly increase as the cost is allocated over 9 tuition months. We again offered some special opportunities for Bellwood families including photography sessions and spirit wear, which all help to provide some revenue for the school. We also join with UUCNH to raise funds through Amazon Smile.

BUILDINGS & GROUNDS

Bellwood continues to work with parents and UUCNH to maintain our building and grounds. During the past year, we performed regular maintenance of carpet, window and gutter cleaning. We had the furnace cleaned and replaced filters. We coordinated with the church regarding a fallen tree (September) and tree branches (January). The tree / branches were removed and the downed phone wire repaired. The tree trimming and removal last year was extensive and we now have a small fairy garden area where our big pine once was. We also purchased and spread playground mulch during the summer of 2021.


Bellwood is currently working with the Church's Memorial Garden Committee. Bellwood is purchasing a bench in memory of Jan Ridenour (founder of Bellwood) for the Church's memorial garden which is scheduled to be delivered in late September.

An area that will be addressed this summer is fencing. We are now contracted with Lowe's to replace the entire length of chicken wire fencing with wooden fencing. We are also researching exterior paint and repairs which will likely take place in 2023.

We are grateful for the continued use of the church facility for K-Kids, special events, meetings, office space, the annual Art Show, and the KidStuff Sales.

CONCLUSION

Because of our partnership with UUCNH, Bellwood was able to help educate and grow 64 young children who we hope will make the world a better place, and we were able to make their world a little brighter, more interesting, and enriched. All of this was possible due to our dedicated, talented and loving teaching staff, helpful parents and board members, our diligent office administrator and a director whose love of childhood and children is unending. We look forward to continuing this tradition and mission next year.

Strong representation by group doing this work for many years. Application submitted last year, UUCNH granted "Candidacy Status" – environmental justice project remaining. Reached out to eight community organizations, most promising responses from:

- HEARTH, North Hills shelter, train participants in designing, constructing and operating a community garden a good match for us.
- Allegheny County Clean Air Now, communities that suffer from pollution from sources on Neville Island, small dedicated group that needs help with outreach, circulating petitions, etc.

Team would like to connect with Justice issues congregation-wide

Participation in monthly National Cohort of GS Candidates (7 churches in similar stage)

Would like to implement recommendations from Energy audit (2018), as part of Capital Campaign.

Plans for re-vamping recycling, composting, waste in community kitchen

Friendly competition with First Church and Allegheny Unitarian to see who can save the most energy and reduce their footprint the most.

Buildings and Grounds – Mark Swihart

2021 was quieter for B&G than 2020. Handyman doing excellent job but volunteers always needed for cleanup and repairs.

Trees removed; office repainted; elevator batteries replaced, and now in compliance; new mail box; Church sign revamped; driveway patching; most of outside stairs replaced as needed, not ideal - different solution in the long run; new dumpster provided by Vogel.

Communications – Fred Geiger and Joyce Kepner

Work on new website began in early 2020 with consensus on messaging to convey who we are. Site is now more professional, thanks to Fred. This is the 3rd website Fred has designed for UUCNH. We were not reaching the people we wanted to reach. Language on website tweaked so that people seeking liberal religion will find us. Less jargon, new site will show who we are and who our minister is through her sermons. *Resources* is a repository of information for members, plus *Serving Others*, and *The Power of Personal Connection*. Gradually replace stock photography with our own photos.

Handicapped accessibility to websites required by law. A plug-in added that allows person to change font size for him/herself. Future plans for advertising on social media to attract visitors to website. Fred would like more feedback from congregants. Link to new draft website.

Personnel Committee - Mark Draa, Chair, Susie Wood, Beth Zak

Develop & maintain a system for reviewing the (paid) staff at UUCNH.

Make annual recommendations to BOT regarding Compensation and Benefits for staff.

Review law, cost of living, annual UUA recommendations.

Last year highlight – Creation of formal Personnel Manual; organize and standardize job descriptions for all employees.

This year's big task – Creation of a standardized review process for the Minister.






BASIC PLAN - \$550,000
