He has made advance preparations and will be available by phone and email, if needed. For the longer term, the Board agreed that we need to recruit back-up for this critical volunteer position, even though we have Pat Bauer on staff.

VIII. Support for LDT Nominations

LDT is still working on securing a list of nominees for Board and LDT positions, so there was no action at this meeting. LDT did request additional information on Board roles and time commitments to assist in their recruiting efforts. Julie agreed to forward some previously developed material.
